



Wiring Diagram for iCS 2 (IC) backwards compatibility.


All connections are made at the Input/Output Terminal Strip.



DCS-MP Manual Dimming Control


Wiring Diagram for iCS 3 (I3) backwards compatibility.

All connections are made at the Input/Output Terminal Strip.





Note: When using external sources for triggering or analog dimming, it is important to use common ground returns for all supplies. A second ground pin is located on Pin 4 of the DCS-MP for this purpose.
